CAUSES AND FACTORS OF ISLAMOPHOBIA: STRATEGIES TO OVERCOME

ABSTRACT:

Phobia as per Merriam-Webster dictionary is an unexplained and illogical fear of something. It is very difficult to know the reasons and the roots of this fear, but this agitation does exist in minds. During past few decades, a terror that had hit the world is Islamophobia: the (unreasonable fear of Islam and Muslims). The main source of spreading this fear in the world is media. Islam is the religion that is less preached and taught in the west. Many people around the world never had any contact with Muslims and Islam. They only take Islam the way their media had portrayed it in front of them. Without having any basic knowledge of Islam that Islam is the religion of Peace, love, and care. They (the effected minds) think that Islam is based on cruelty, suicide bombing, and violating human rights. This wrong and negative perception of Islam had led the term Islamophobia in western society and in new generation of Muslims too. After 9 September 2001, every incident of target killing, bombing and terrorism is linked with Islam without knowing the facts. Many studies have been conducted against Islam, but none have been conducted to protect and secure Islam and to erase islamophobia from west. If Muslims want to have their sacred position back in the world, they need to follow the guidance by Allah and His Messenger (PBUH). The Muslims scholars should put more efforts to bring the positivity of Islam in front of all mankind.

"Islamophobia" is a combination of two words, Islam, and Phobia. Islam refers to monotheistic religion or belief which states that Mohammed is the prophet of Allah (Rasulullah). Phobia is an extreme and irrational fear of a thing" ¹

Elkassem says that "A phobia is illogical fear of different phenomena. The phenomena include a particular object, situation, or behavior. It is very difficult to determine the significant factors that are affecting the people or group of people" ²

Over the mankind history, the phobia may affect individuals but there has been no phobia which had affected the world. Unfortunately, now there is a phobia that is affecting the whole world and because of this phobia the people of all religion have created intrinsic war in their minds which is Islamophobia.

"Islamophobia is any distinction, exclusion, or restriction towards, or preference against, Muslims (or those perceived to be Muslims) that has the purpose or effect of nullifying or impairing the recognition, enjoyment or exercise, on an equal footing, of human rights and fundamental freedoms in the political, economic, social, cultural or any other field of

public life".³ (3)

Although fear and hatred of Muslims is as old as Islam itself, the term "Islamophobia" is a relatively recent neologism that is used to "draw attention to a normalized prejudice and unjustified discrimination against Muslims." ⁴

"The term has been popularized because of the resurgence in the post-Cold War and post-9/11 United States of the phenomenon it describes" ⁵

According to the 1997 report by the Runnymede Trust's Commission on British Muslims and Islamophobia, hereafter referred to as the Runnymede Trust report, "Islamophobia includes discrimination against Muslims in employment practices, the provision of health care and education; exclusion of Muslims from government, politics, and employment (including management and positions of responsibility); violence toward Muslims including physical assaults, verbal abuse and vandalizing of property; and prejudice against Muslims in the media and in "everyday conversation"

HISTORICAL FACTORS:

There is the possibility that "Islamophobia is an entirely new and contemporary phenomenon, relevant only to the here and now and quite

independent of...the past's historical manifestations and contexts."⁷

"This approach is generally rejected; nearly all the works reviewed above agree upon the importance of historically contextualizing Islamophobia rather than viewing it as an isolated contemporary phenomenon." (8) Writers of latest works also verify this assessment. For example, Anas Al-Sheikh-Ali, one of the sponsors to John Esposito and Ibrahim Kalin's 2010 collection on Islamophobia, states that "it is clear that historical Islamophobia is informing contemporary Islamophobia."

"Islamophobia, including the perception of Muslims as the "other" and the perceived superiority of the West, should be seen as emerging from not only the contemporary context of perceived civilizational clash, but also from other factors including European colonialism" ¹⁰

whether or not one accept as true between Islam and west a clash of civilization is unavoidable, it looks that Europe's initial encounter can be

classified as a clash which left psychological marks. Jane l. Smith, authors of work on Islam in America, states

"Centuries of encounter between Islam and Western Christianity, including the endemic growth and spread of the frontiers of Christian territory, as well as the long, drawn-out battles and skirmishes of the Crusades, left on both sides a legacy of misunderstanding, fear, prejudice, and, in some cases, hatred" ¹¹

In year 1492, Christian conquered Islamic Spain by destroying the Jews and Arabs. The Jewish and Arab was forced to accept Christianity. The Christians are the one who introduced the term "Others "in the Europe. The Arabs and Jews were considered by the Christian as the people with the wrong faith and religion. These two groups were considered as the people with no God and were treated badly even as equivalent to the animals. Historically the Christian in Spain had made the huge expulsion of Jews and Arabs. This act was the show of power and creation of differences between humanity.

"Through the end of the Crusades in the fifteenth century and the beginning of the colonial period in the late fifteenth and early sixteenth century, the period of European ascendancy continued. Technological advances during this period meant that the Europeans were able to finally oust the Arabs and Turks from their territory altogether. In addition, Europe began to expand outward, looking to dominate not only the Middle East, but the whole world" 12

9/11 event:

Since the attack on the World Trade Center in 2001, the Islamophobia had increased at a global level. "The involvement of Muslims in that terrorist attack at World Trade Center was associated with the Islam religion to destroy the peaceful image of Islam in all over the world" ¹³

However, in the history of the world there have been many attacks and crimes happened all over the world, but the terrorists have never been associated with their religion and the respect of the religion was maintained across the globe. But the 9/11 event had been used to increase and promote the Islamophobia across the globe.

"The ISIS had made the situation more worse as the Islam was portrayed as the religion of violence" the misunderstanding of Islam has portrayed that the disciples of Islam has spread the Islam by destroying the followers of other religions "The people of different Western countries even categorized the Islam and the Muslims as an alien and the religion of bloodshed which triggers the intolerance level of the people of different religions. The Muslims are treated badly in every field, they are considered as separate nation and even most of the time they are not included in the strategic planning even at government level" 14

The Muslims have been facing lots of problems in different Western countries. "They are facing problems not only at their Islamic centers but also at different social and public places. The problem is that the world has been using the terrorist attacks, 9/11 event, ISIS violence and Islamophobia interchangeably" ¹⁵

CAIR expresses with "cautious optimism that America may be witnessing a leveling-off of the post-9/11 backlash against Americans of the Islamic faith. Yet the increase of incidents at Muslim institutions (such as mosques) rose from "221 cases in 2006 to 564 cases in 2007 to 721 cases in 2008," representing a "28 percent increase from 2007 to 2008. There was a similar increase of reported discrimination in schools: 118 reported in 2007 and 153 reported in 2008 -- this is an increase of thirty-one percent" ¹⁶

The Islamophobia and media contribution have been restricting the voice of Muslims against violations against them. In all over the world it is known that the Muslims are badly treated in some countries which are under control of non-Muslims. Like Kashmir, Palestine and Burma, the Muslims are badly captured and are not given basic human rights for livings. But these practices are not properly acknowledged, and non-satisfactory actions have been taken by the promoters of peace. On the other hand, if something bad happens with non-Muslims by the Muslims in the response of their inhuman treatment then they are highlighted as the

terrorists and related to the Islam directly to humiliate the true and peaceful teachings of Islam. "The Muslims are treated badly in every field; they are considered as separate nation and even most of the time they are not included in the strategic planning even at government level" 17

TERRORISM, VIOLENCE, AND ISLAMOPHOBIA:

Terrorism and violence both had lifted the negative perceptions of Islam and Islamophobia. In fact, it has become a belief across the globe that Islam is the religion which has been nurturing extremism and terrorism in all over the world. The mosques and Islamic centers are considered as the places of terror and trainers of terrorists which are teaching the Muslims about the terrorism and in fact now the Muslims who are more practicing Islam have been considered to practice more terrorism in the public places. "The Muslim men who have beard as per the Islamic standards and the Muslim women who have been wearing hijab are considered as terrorist or considered to have been taking trainings for violence. Teachers wearing hijab are not appointed in Germany" 18

Even if an event of violence or terrorism takes place in any part of the world, the detectives probably consider the practicing Muslims as the suspects. Therefore, the Islamophobia has been creating problems for the practicing Muslims across the world. This is the reason many Muslims are moving towards self-generated concept called modern Islam or moderate Islam.

"The modern Muslims or moderate Muslims are not practicing Muslims

Consequences:

"The promoters of Islamophobia must have realized the limitless consequences which can destroy societies across the world. On the other hand, this has changed the mindset of Muslims who are not appreciating to practice the true teachings of Islam as they have also started believing that if they completely follow the true teachings of Islam, they become violent and terrorist and may start corruption across the world. The above discussed two consequences of Islamophobia have changed the beliefs of the people of other religion but also changed the beliefs of Muslims. The most disturbing significant problem for the people of the whole world is

STRATEGIES TO OVERCOME:

The international conferences will allow the general public to participate in open debate and open question and answer session to create better understanding of Islam and collectively put effort to minimize the Islamophobia to promote brotherhood to the whole mankind and can reduce the increasing rate of violence, threat, terrorism and destruction.

The international conference does not include media, because the media can only represent the biased information and restrict the audience to know and to put questions for better understanding.

The international conferences allow gathering more people and exposing them to the expert speakers with direct interaction which is free from any bias and the public is allowed to develop opinion based on the judgments of evidences presented in the sessions.

Furthermore, the people who want to learn and want to ask more would be provided more opportunities for open discussion with the experts so that the people who would learn more and more and can put their views directly in front of the experts.

11. Use media to promote the situation of biased media

The media is the key factor to promote the message of Islam. The limitation of international conferences is that few people can have access to these conferences. The media can approach anybody at his place across the globe.

The best way is to make videos of international conferences and put them

on the media so that people who do not come to the conference would see the sessions on the media.

TV and the YouTube are the better media to broadcast the conferences across different parts of the world. The benefit of YouTube is that it is accessible anybody anywhere and anytime.

The Muslims world should get together to make continuous effort to promote the true understanding of the Islam. The films and drama industries must work to promote the true essence of Islam by making new films and dramas with strong script to put counter effect against Islamophobia.

The journals should be created on Islam more and more and the Muslims scientists are invited from different parts of the world to do scientific research and get them published more and more so that the print media would play its part to promote Islam more and more.

The magazines and radio must include articles and programs to promote the true understanding of the Quran which will be useful to counter the Islamophobia.

The researchers must do scientific studies to tell the world that how the Western world has been using media to portray the negative perception of Islam and promoting Islamophobia without targeting anybody.

12. Make effective dramas and films to present the true picture of Muslims

The writers, directors and producers have been making films in the world to present the negative perception of the Muslims in their films. They use the films and dramas to promote Islamophobia by presenting the characters of Muslims as violent and terror.

Even in Pakistan the writers, directors and producers are making films and dramas based on entertainment which are causing the youth of the population deviated from concentrating on Quran. On the other hand, they are also making films and dramas to promote Islamophobia.

There are few movies in Pakistan which also based on promoting Islamophobia in Pakistan. They portray the characters of "Mullas" as fundamentalists and extremists. The films and dramas are continuously portraying the image of extremists Muslims as causing threats to innocent people.

So, the Muslims are portraying the negative image of the preachers of Islam to misguide the people of the society and Allah clearly mentioned in the Quran that those people who want to bring changes in the right path of Islam will be destroyed in this world and hereafter as well.

The Muslims have to promote their bright history in media by making films and dramas on Muslims history. The general public should know the bright histories of Muslims. They should also know how the Muslims were able to rule the world.

13. Promoting best presenters of Islam to explain the true picture of Islam

The preaching Islam is not the enforcement, but it is an invitation to the mankind. In fact, the presenters of Islam should follow the styles of the last prophet Muhammad (P.B.U.H).
